1. The propensity of a domestic animal to behave in ways i.e., running, bucking, biting, kicking, shying, stumbling rearing, falling or stepping on, that may result in an injury, harm or death to persons on or around them.
2. The unpredictability of a domestic animals reaction to such things, as sounds, sudden movement and unfamiliar objects, persons or other animals.
3. Certain hazards such as surface and subsurface conditions.
4. Collisions with other domestic animals or objects: and the potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the domestic animal or not acting within such participant's ability.

I acknowledge that there is the possibility of injury when riding or working with horses.
